To be an Associate Member of VACCHO, organisations must be either an Aboriginal Community Controlled Health Service or an Aboriginal Community Controlled Health Committee, and delivering health related services and community support services.

An Aboriginal Community Controlled Health Service is a service that is:

- 1. an incorporated Aboriginal organisation in Victoria
- 2. initiated by a local Aboriginal community
- 3. based in a local Aboriginal community
- 4. governed by an Aboriginal body which is elected by the local Aboriginal community
- 5. delivering a holistic and culturally appropriate health service to the Community which controls it².

PART C: Process

Associate Membership

- (1) An application to become an Associate Member of the Association must -
 - (a) be made in writing and be in a form approved by the Board; and
 - (b) contain such information required to assess criteria for qualification as an Associate Member as determined by the Board from time to time; and
 - (c) be lodged with the Secretary of the Association.
- (2) As soon as practicable after the receipt of an application, the Secretary must refer the application to the Board.
- (3) The Board shall determine whether to approve or reject the application. The Board's decision in this matter is final.
- (4) The Board, in deciding to approve or reject the application, shall be guided by the criteria referred to in rule 4B(1)(b).
- (5) If the Board approves an Associate Member application, the Secretary must, as soon as practicable, notify the applicant in writing of the approval.
- (6) The Secretary must, within 28 days after the Associate Member approval enter the applicant's name in the register of Members.
- (7) An approved applicant for associate membership becomes an Associate Member and is entitled to exercise certain benefits as an Associate Member as determined by the Board from time to time (noting an Associate Member has no Member rights as described in these Rules) when its full corporate name is entered in the register of Members.
- (8) Any benefit accruing as or obligation of an Associate Member -
 - (a) is not capable of being transferred or transmitted to another person or organisation; and
 - (b) terminates upon the cessation of membership of the Associate Member whether by dissolution or resignation or otherwise.
- (9) No entrance fee or annual subscription is payable by an Associate Member of the Association¹.
